<p>Many states have legislation for RTP and for education (aka identification) of concussion. Fewer states have language about Notification (communication) and RTL. Prior to approval for GRTP steps, is there notification that student is 'Back to Baseline' symptomatically from School to Medical?		
School collects WRITTEN clearance from approved healthcare provider before allowing back to sport? Back to PE? Back to play at recess?
